Fireworks Display

This year's fireworks display was another great success with crowds in excess of 10,000 attending the event.

The only disappointment was the number of volunteer collectors who turned up on the night. In total there were 19 collectors out but despite this they collected £3,152.61.

In past years the Town Council made up the collection to £3,500 which is then divided equally between the Mayor's two charities.

Members are asked to consider this report and decide if the collection should be made up to £3,500.

Band D Properties - Caerphilly Town Council area

The Town Council has received notification that the number of Band D equivalent properties in its area is 6121.31 for 2016/2017.

If members set a Council Tax of £12.00 for each Band D equivalent property tax 2016/17 it will raise a Council Tax of £73455.72.

Members are asked to determine the Council Tax for 2016/17 and the amount of precept it wishes to raise.

Re Floral town centre displays.

As you are aware from our past conversations the County council is proposing as part of its MTFP savings to not undertake the floral displays in 2016.

At the locations we have undertaken these in the past, I have written to the 4 clerks to out line the position and in your town councils area provided above a few options for your council to consider.

The above spread sheet is based on the past number of baskets we used in Caerphilly, two other options are out lined for your councils consideration.

You may wish due to the cost to consider others, if so, please as a matter of urgency advise me on this. Our plant supplier and watering contractor have recently provided costs for 2016, these are for existing locations where existing brackets are fitted.

The plant Nursery has asked we confirm the positon as to progressing the projects as soon as possible, before the end of November due to him having to order/ pay for seed etc.

The area parks officer will organise the works, Simon Beacham, the colour combinations have been set by his co officer, Amanda Noden who has completed this exercise in past years with very good results.

I would also confirm any vandalism or vehicle damage to the displays once sited in the town will fall to the community council to fund such repairs or replacements.

Any changes or deletions would need to be with me as soon as possible, I would be happy to discuss any points you may have.

Payments for the displays and maintenance work / watering would be 50% in May and the final payment in September 2016.

Finally, in option 3, I have quoted the use of plastic baskets, our plant supplier has confirmed he has been asked to sell off over a 100 plastic self watering baskets, these being 2/3 year old on behalf of Merthyr Tydfil borough Council, we are informed the council are not doing displays any more.

We have these same baskets at our other locations and the benefit from the use of these is on the watering costs, it basically reduces the watering costs by 50%. The cost of these cup and saucer baskets when new is around £30 each, we have been offered the ones at the nursery supplier on behalf of the council at £15 each.

Can you consider this option and or give me or Simon a ring to discuss any issues you may have.
