25 MINUTES OF THE ORDINARY TOWN COUNCIL MEETING HELD ON MONDAY 20TH MAY 2019

Minutes of the Ordinary Town Council Meeting held on Monday 20th May 2019 were received, confirmed, and signed.

26 MATTERS ARISING

Minute 16

The response received from CCBC in respect of the enforcement of the night time taxi rank suspension, and the relocation of an APNR camera was noted.

Minute 18

Flyposting had not been removed. The matter had been referred to CCBC.

27 COMMUNITY SAFETY MATTERS

Various techniques were employed to establish "Your Voice" priorities including Twitter and On Demand App. For the next six months the top two priorities will be:

- Off road motorbikes, stop sticks will be used if necessary.
- Drug cultivation on Lansbury Park / Graig y Rhacca.

There will also be a continued focus on anti social behaviour in Cardiff Road.

During July there will be a number of music events at the Castle. There is the possibility of using taxi marshalls to send people in the right direction. It was suggested that a temporary taxi rank in Morrison's car park should be considered.

Other matters raised:

- Beggars in Cardiff Road.
- Road traffic accident at junction of Pontygwindy Road / Dol y Felin Street on 13th June.

28 TOWN MAYOR'S DIARY

The Mayor had attended the Malcom Uphill 50th anniversary of the first 100mph lap at the Isle of Man TT races.

The Mayor will be arranging a launch date for his two charities, Velindre Hospital and Caerffili Lions.

The Deputy Mayor had attended a charity concert at the Wesley Methodist Church.

29 ENVIRONMENTAL MATTERS

The following matters were raised to be referred to CCBC:

- Aggressive approach of Talk Talk representatives who have a stand on the pavement outside Barclays Bank, Cardiff Road.
- Alternative of wild flower sowing to reduce frequency of grass cutting of verges and roundabouts.
- Frequency of cleansing of town centre and litter enforcement.
- Unsatisfactory location of commercial waste bins on pavements outside restaurants eg Casa Mia.

Caerffili in Bloom group will having another litter pick before Wales in Bloom judging day on 6th July.

30 TOWN CLERK'S REPORTS

1 Community Infrastructure Levy (CIL) Working Group

Members noted the position on the CIL fund and the updates on the Welsh National Anthem Memorial Project and electric vehicle charge points where CIL funding commitments have been made.

The CIL Working Group had made recommendations concerning the funding of the door coin entry systems at the bus station public convenience which reflected the position of CCBC at the

time. However there had been a change in circumstances since the Working Group met and the following was resolved:

- To support the Caerphilly County Borough Taxi Drivers Association to maintain public access to the bus station public convenience. The Town Council will allocate £5000 of CIL funding to meet the cost of the two door coin entry systems.
- On the basis that CCBC as the building owner will be responsible for the procurement of the two door coin entry systems the Town Council agrees to reimburse the cost to CCBC from the CIL account
- 3 CCBC be requested to amend the tenancy agreement to require public access to the toilets on a daily basis during specified hours and for the period the tenancy remains in force in order to justify the CIL investment and ensure a public benefit is maintained.

It was also agreed that £350 of CIL is used for a new direction sign to the War Memorial on Caerphilly Common which commemorates a Canadian Spitfire pilot.

2 Community Infrastructure Levy

It was noted that the Town Council will receive a CIL payment for 2018/19 of £7,379-79.
