Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £ 5650 _____ under section 137. These payments are included within 'Other payments' in the Accounting Statement.

Auditor General for Wales' Audit Certificate and report

I report in respect of my audit of the accounts under section 13 of the Act, whether any matters that come to my attention give cause for concern that relevant legislation and regulatory requirements have not been met. My audit has been conducted in accordance with guidance issued by the Auditor General for Wales.

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2022 of:

Auditor General's report

Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources (value for money).

Basis for Qualification

In my opinion, the Council does not have proper arrangements in place to secure value for money and the accounts contain expenditure that in my opinion is contrary to law

- The Council has established standing orders and financial regulations to ensure that the Council achieves value for money when procuring goods and services. However, my audit identified that the Council disregards its own standing orders and financial regulations on a recurring basis. I identified 7 transactions with a combined value of £39,778 for which the Council failed to comply with its own regulations. There is no evidence that the Council decided to waive the standing orders and financial regulations for these payments and no adequate explanation was provided.
- Therefore, in my opinion, the Council acted unlawfully in awarding these contracts.

Other matters arising and recommendations

There are no further matters that I wish to draw to the Council's attention.
