### Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2025 of **Caerphilly Town Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

#### Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

#### Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council:

#### Standing orders

Council's standing orders are not in accordance with One Voice Wales' model standing orders and financial regulations.

We recommend that the Council ensure that their standing orders are in line with One Voice Wales' model standing orders.

#### Council did not record the total precept amount within their minutes

The Council did not include the agreed total precept amount within the minutes, only the Band D equivalent.

We recommend that the Council include the total precept amount within their minutes.

#### Tax payable on the Chair's allowance

The Chair received an allowance for the 2024-25 financial year which was greater than £156. As this exceeds the HMRC allowed payment of £156, it is subject to PAYE. No PAYE deductions were made by the Council.
